The EHESP sets up an Executive Health MBA in partnership with the ESCP-EAP and LSE

Rennes, 28 May 2008. The EHESP, ESCP-EAP and London School of Economics (LSE) have joined forces to set up an international Executive Health MBA to meet public health requirements and draw up health organisation and management strategies.

Pathologies change and appear to become more chronic. Care organisation is gradually becoming more localised and health services are expected to be increasingly efficient. Given these changes within the care system organisation, a combined knowledge of management and public health is required to define national and local policies and draw up strategies for establishments and their management. The **Executive Health MBA** is designed to meet this requirement.

The **Executive Health MBA** sets out a common culture for those managing administrative, medical and care services in the health system to provide them with a shared basis of concepts, standards and approaches. The **Executive Health MBA** course requires an attendance of 55 days and leads to a diploma issued jointly by the EHESP, ESCP-EAP and LSE. It is open to young directors of public or private health establishments with 3 to 10 years experience, doctors who are actively involved in the management of their establishment or service, care co-ordinators and managers of health-related industries or regional, international or European organisations.

The course comprises several public health modules ("Health Policy and Management", "Social and Behavioural Sciences", "Epidemiology", "Bio-statistics", "Environmental and occupational Health") and management modules ("Organization theory", "Strategy", "Accounting", "HRM and Ethics"), cross-subject modules and case studies. Tuition is provided by lecturers and international experts from the EHESP, ESCP-EAP and LSE as well as from the following establishments: Center for Global Development, Columbia University, CNRS, Fondation Nationale des Sciences Politiques, Georgetown University, Harvard School of Public Health, Health Development Communication, INRA, INSERM, OMS, Soul City Institute (South Africa), Universités de la Méditerranée, Paris V Descartes, Paris VI Pierre et Marie Curie, Paris VII Diderot, Paris X, Paris XII, Poitiers, University of Portsmouth.

Tuition is in English and language courses in French and English are organised as appropriate. The course is held in Paris (20 weekends), London (1 week), Berlin (one weekend) and Madrid (one weekend). The course starts on 5 September 2008.

About:

EHESP: The Ecole des Hautes Etudes en Santé Publique [School of Public Health] took over the missions of the Ecole Nationale de la Santé Publique [National School of Public Health] in Rennes and is broadening its scope to include new specialties, diplomas and international collaboration. It provides training for those involved in management, inspection or control in the health, welfare and care domains. It provides higher education in public health (undergraduate, graduate and post-graduate), and in 2009 will be setting up a Master of Public Health and public health PhD facilities.
