EHESP : the only school of its kind in France




The EHESP is a public institution with a dual role of education and research into public health and social welfare. It fosters team-work between the disparate cultures of public health and management.

Role of the tutor

As the student's correspondent during the internship, the role of the internship tutor is to :

- design a programme in line with the objectives of the placement validated by the EHESP
- facilitate contact and exchanges between the student and staff of the host institution
- monitor student progress through to the final assessment

The student also has an academic tutor at EHESP whose role is to provide pedagogical assistance throughout the internship.

Health care institution management 2 months (mid-August - mid-October) *e.g.: evaluation of patient experience and its integration into Lean Management in University Health Centre of Quebec (Canada)

Social care institution management

2 months (September - October) *e.g.: ReMediA : Creation of medical care network and support of patients suffering from Alzheimer and their caregivers in Marakech (Marocco)

Master of Public Health

M1 (optional internship): from 2 to 3 months (May -July) M2: 5 months (February - June)

*e.g.: cost-effectiveness of Five mental health interventions in New York City (United States)

Master in administration of public health policies and programs 4,5 months (March - June) *e.g.: involvement of actors in the implementation of the Health Development Municipal Plan in Ouagadougou (Burkina Faso)

Master in Disability and Social Participation 4,5 months (mid-April - late August) *e.g.: research study on the practices of intellectual disability service agencies and the social participation of users and families (Canada)
