## Public Health Doctoral Network

The network is led by EHESP and brings together 9 partner doctoral schools. They cover a number of complementary domains throughout France: biostatistics and information sciences; epidemiology; occupational health and environmental sciences; economics, management, law and health policy; social and behavioral sciences and nursing and paramedical sciences.

The aim of the public health doctoral network is to facilitate PhD students' multidisciplinary education and to develop their interdisciplinary and international practice that will, in the long term, lead to the emergence of a community of professionals and researchers sharing a common public health culture.

## Strong international relations

### Creating and promoting a network of partners

EHESP's goal in developing strong international relations is to create and promote a network of partners to provide students with an international education and encourage international mobility. These partnerships are also reflected in hosting foreign students and teachers and in the creation of joint degree programs.

### Transferring skills

The international relations develop and build human resource capacities in health and welfare services of the partner countries through training, assessment and strategic consulting actions.

### Contributing to international research

They also bring together teams from around the world to cooperate on EHESP. EHESP has developed a wide range of training and research partnerships with universities in Europe and the Mediterranean region (Algeria, Denmark, Germany, Lebanon, Morocco, Poland, Spain, The Netherlands, United Kingdom); in the Americas (Argentina, Brazil, Canada and the USA); in Africa (Burkina Faso, Ivory Coast, Republic of Congo) and in Asia (China, Singapore, Vietnam).
